3. **Card Deposit, Entrance Fee Payment Method**
Attach Entrance Fee & Card Deposit (S\$5350 + S\$200) by crossed-cheque made payable to "The Japanese Association, Singapore" with application form and submit it to the Front Office.
4. **Monthly Subscription Fee & Building Maintenance Fund**
Above will be billed together with other payments incurred later.
5. **GIRO**
All members are strongly encouraged to apply for GIRO for their payments through the enclosed GIRO form.
6. **Membership Card**
Membership cards are not transferrable and must be returned to the Association's office together with form for Notice of Resignation upon member's resignation.
