4. **Special Skill, Hobbies & Qualifications**
Fill in the appropriate code numbers of your special skills and hobbies from the list in attached FORM 1. Kindly specify those that are not found on the list.
5. **Card Deposit, Entrance Fee, Subscription Fee & Building Maintenance Fund – Individual Contribution**
