REMARKS					

I 法人会員規定

(日本人会細則第4条)

- 1 法人会員は、当該法人所属の本邦派遣日本人全員をノミニーに指定しなければならない。尚、その他の日本人についてもノミニーに指定することができる。これにより、指定されたノミニーは会則第 13 条に従い、正会員となる。但し、会則第 11 条による臨時会議に該当する者を除く。
- 2 法人会員は当該法人に所属する者で、会友となる資格のある者をノミニーに指定することができる。 これにより指定されたノミニーは会則第 13 条に従い、会友となる。
- 3 法人会員の入会金及び会費並びにそのノミニーの入会金及び会費については総会及び理事会によって 現行、表1のように定められている。
- 4 ノミニーの弟子は、日本人学校運営理事会の別途定める規定に従い、日本人学校の入学に際し、優遇を受けることができる。
- 5 法人会員は総会において1票の議決権を持ち、代理人によりその議決権を行使することができる。代理人は、当該法人会員に所属するノミニー正会員でなければならず、当該法人会員の役員会あるいは然るべき機関の決議によって、任命された者とする。

この権限委嘱が有効になるためには、その権利が行使されることになる総会の遅くとも 24 時間前までに日本人会事務局に提出しなければならず、一旦事務局に届け出のあった代理人の登録は、法人会員が当該代理人への委嘱を解消するまで有効とする。上述の代理人が総会に出席できない場合には、当該法人会員に所属するノミニー正会員もしくは総会議長に法人会員の議決権の行使を委任することができる。理事会は、法人会員に対し、総会の通知を遅くともその開催日の一ヵ月前までにださなければならない。

CORPORATE MEMBERS (Clause 4 of Japanese Association's Bye-Law)

- 1 Corporate members shall designate all Japanese staff assigned from Japan as nominees for membership in the Association. In addition, other Japanese may also be nominated for membership. In compliance with Rule No.13, the nominees will become Ordinary Members with the exception of Visiting Members as stated in Rule No. 11.
- 2 Corporate members may designate members of their non-Japanese staff as nominees, according to Rule No.13. These nominees will become Associate Members.
- 3 The entrance fees and monthly subscription fees of Corporate Members and their nominees have been decided at the Annual General Meeting and the General Committee Meeting, as illustrated in Chart 1.
- 4 The children of nominees shall be given priority over other members to enter the Japanese School, according to the regulation set forth by the Japanese School Management Committee.
- 5 Each Corporate Member is entitle to one (1) vote at each General Meeting. The voting right of the Corporate Member shall be exercised through a representative. This representative must be an Ordinary

Nominee Member nominated by the Corporate Member by resolution of its directors or other governing body.

The authorization of a representative to attend and vote at any General Meeting in order to be valid shall be delivered to the office of the Association for registration not less than 24 hours before any General Meeting at which it is to be exercised and such authority shall be deemed to be valid and effective until revoked by the Corporate Member by written notice to the Association.

In the event that the representative is unable to attend any of the General Meeting, he may appoint a Ordinary Nominee Member of the Corporate Member or the Chairman of the General Meeting to vote as his proxy by submitting a letter of proxy not less than 24 hours before the General Meeting. The notice of any General Meeting shall be given to the Corporate Members not less than one month before the date of the General Meeting.
